A message from our Chairman, Michael Blackie

FORTY YEARS ON

There is a long connection between Jersey and the operas of Gilbert and Sullivan. The Edwardian musical theatre star, Sir Seymour Hicks, was born in St. Helier exactly a hundred and fifty years ago. Though the family moved to England soon afterwards, as a nine-year old he was in one of the very first amateur productions of "HMS Pinafore", appearing as Little Buttercup at his school in Bath. In the last century, the Jersey Green Room Club regularly performed the operas as did, more latterly, St. Mark's Players, but it was not until 1980 that a group of friends, some still Members, came together to form the Society.

Our early productions took place at the old Lido de France, part of the Hotel de France, the owner of which, the late Ian Parker, shewed great generosity to the Society in allowing us not only to perform there, but also to hold all of our rehearsals there free of charge.

A major step was taken in 1986 when we made the move to the Jersey Opera House with our first production of "The Gondoliers". Since its formation, the Society has produced all the operas ("Princess Ida" and "Utopia Limited" only in concert form), most of them several times. They continue to be well received, though the absence of Gilbert and Sullivan in schools for the last generation or so presents us with challenges – a nice dilemma that, as the Judge opines, calls for all our wit.

Michael is retiring as Chairman at the AGM next week. The Society thanks him for his many years of service and looks forward to seeing him on stage in further productions.

Remembering other inspiring women in the law

Anita Regal

Anita Regal, who died in April of this year, was Jersey's first female Advocate, being sworn in by the Royal Court in 1968. She spent more than 50 years with the law firm Bedell Cristin rising to be Senior Partner.

As well as her career in the law, wife and mother Anita, a prominent member of the local Jewish community, had a major role in the charitable life of the Island. She was a



member of the Soroptimists and a founding member of the Whiteley Association for professional women of which she became Honorary President.

Today around 40% of practising Advocates in Jersey are women.

Ruth Bader Ginsburg



Ruth Bader Ginsburg, who died last year, was an associate justice of the Supreme Court of the United States, the first Jewish woman and the second woman to occupy that position. Facing gender-based discrimination herself despite her exceptional academic credentials, for much of her legal career she was an advocate for women's rights and gender equality.

Her work led to significant legal advances for women under the Equal Protection Clause of the Constitution. Another trailblazing judicial figure and feminist icon for our age.
